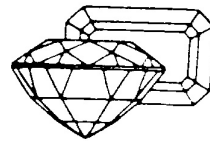

ALL AMERICAN CLUB

Since the powers that be have shortened the informational sheet regarding the All American Club Award Program to only the Report Form Instructions, the following information will be important for all clubs contemplating entering a club book this year.

Established in 1967 by the American Federation of Mineralogical Societies and the seven regional federations, the All American Club Award is meant to:

Encourage local club members to share expertise and enthusiasm for the hobby within their respective regions.

Provide a model for organizing an annual historical account for the posterity of each club, and

Offer an opportunity for national recognition of exceptional clubs.

Just as the award is focused on quality effort that enables members to grow and clubs to flourish, it is also focus on quality that the All American Club Award judges seek in evaluating applications for regional and national honors. Completeness of the report is important, and quality is valued over quantity. Reports must be received by the club's respective regional chairperson by February 28, 2012.

This is not a competition of one club against others. This is an evaluation of quality based on a standard of excellence. Gold, Silver and Bronze awards are granted for achievement of points in the appropriate scoring range. Only the top regional and national awards are determined on a high point basis. To allow more equality, separate top awards will be given for large clubs (100 or more members), small clubs (up to 99 members) and organized junior divisions (5 or more members).

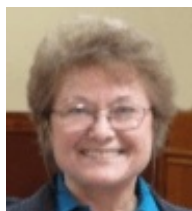

THE WEB SITE CONTEST IS COMING!

Webmasters are invited to enter the 2012 Web Site Contest on behalf of their societies.

The annual Web Site Contest attempts to determine the effectiveness of a society's web site in providing information needed to meet certain goals. In general, judging is based on the standard that the web site should: (1) attract new members; (2) provide information to members; (3) aid in the public promotion of society's activities, such as shows; (4) and fulfill the mission of the society. Also, some basic technical features need to be functional on the site.

The Contest Guidelines and Score Sheet forms have been modified for this year's contest to better rate these objectives. The guidelines coupled with the score sheet offer excellent references to help you tune up your society's web site or build one for the first time.

Webmasters wishing to enter their society's web site should download the following files from the CFMS web site: 1. Contest Overview; 2. Score Sheet Guidelines; 3. Entry Form; and 4. Score Sheet.

You can access information and forms in pdf format on the CFMS website (www.cfmsinc.org); click on "Forms." All of the 2012 contest forms are at the top of this page. If you have difficulty accessing the forms, just let me know and I will email you the forms as attachments.

The fill-in feature of the entry and score sheet forms works best using Adobe Acrobat Reader, Version 9 or higher. If needed, visit www.adobe.com/products/reader for a free update.

Save the files to your hard drive then fill in the entire Entry Form and the top part of the Score Sheet. Please **rename the files so that your society's name is included**; example:

Let's achieve this level of excellence again!



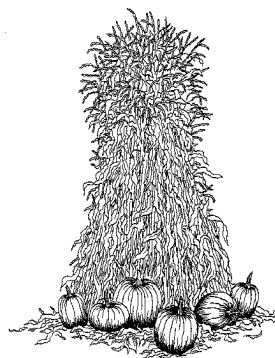
AFMS ENDOWMENT FUND

REVOCATION OF TAX EXEMPTION

The IRS revoked tax exemptions for a substantial number of organizations for failure to file Form 990N for three consecutive years.

It is time for each society to ensure that more than one individual in each society is responsible to make sure the filing is completed each year. Verify that the Form has been sent to the IRS for prior years and if not file as soon as possible. Filing information is available at the IRS website. Save headaches and money as the process for reinstatement requires much time, effort and a \$100.00 User Fee.

For societies with tax years starting January 1, 2010, they must e-file with the Franchise Tax Board using e-filing of Form 199N. Information for e-filing is available at the Franchise Tax Board website. Both the IRS and Franchise Tax Board, admonish e-filing is only available if gross annual receipts are less than \$25,000.

MEMBERSHIP COMMITTEE

Membership Applications

It's safe to assume that each Society has an application form that is provided to prospective new members. One issue with which some societies have difficulties pertains to pro-ration of dues. After all, if YOU were to join an organization (that didn't pro-rate dues) in November by paying a full annual dues amount, only to be billed again in January for another year's membership, I'm sure you'd be upset (this assumes that the organization invoices each member once each year – usually January 1st – rather than on the anniversary of each member's original application).

One solution that works very well is to pro-rate membership dues (for new applicants) throughout the year on a quarterly basis. As an example, let's assume that your society's annual dues amount is \$20.00 for a single adult member. If receiving an application in the first three months of the year, the full \$20.00 would be charged. If an application is received in the second quarter of the year, only \$15.00 would be charged.....3rd quarter - \$10.00 and 4th quarter - \$5.00. In this way, some degree of 'fairness' can be achieved and new members wouldn't be alienated from the very beginning of their association with your society.

Additionally, your Board of Directors may find it wise to establish a policy wherein applicants who pay the 'full annual dues amount' in the 4th calendar quarter of the year receive membership for the remainder of the current calendar year as well as the entire following year. It helps reduce the number of new members who join in the Fall only to not pay their renewal dues in January.

The contest is open to all editors of societies in the CFMS. The 2012 contest covers bulletins and articles **published from January 2011 to December 2011. Deadline for all entries is December 15, 2011.**

The Rules and Procedures as well as all forms can be downloaded from the CFMS web site (www.cfmsinc.org). If you need help downloading forms, please contact me and I will make sure that you get copies.

The Rules and Procedures have been updated this year, so please review them carefully. Also, the score sheets have been updated to conform to the AFMS scoring for more uniform judging.

For Bulletin entries, please remember that you must mail in FOUR bulletin copies – two copies of your MAY 2011 issue and two copies of another 2011 issue of your choice. Fill out the top of the Bulletins Score Sheet and attach a copy to each bulletin copy.

Editors should also submit appropriate articles (published in 2011 bulletins) from your individual club members. There are several categories: Adult articles, Junior articles, Adult Advanced articles, Adult or Junior Features (written or drawn) and Adult or Junior Poems. Fill out the tops of applicable score sheets and attach them to all entry copies.

The Special Publication category is judged only by AFMS at this time, but must be submitted to the CFMS Bulletin Aid Chair (only one copy is needed for the Special Publication). There is a link to the AFMS score sheet to be used for this category posted on the CFMS web site in the Contest area. Just fill out the top of the score sheet and send a copy with the Special Publication.

CFMS PLAC-South

This year California saw the passage of Assembly Bill 628, The Inyo Trails Bill. This bill was signed into law by Governor Jerry Brown on October 7, 2011. The County of Inyo is the 2nd largest county in the United States in area, yet only 2% of this land is inhabited and 92% of the land in Inyo County is federally administrated public land.

This bill would, until January 1, 2017, authorize the County of Inyo to establish a pilot project that would exempt from this prohibition specified combined-use highways, except as provided, in the unincorporated area in the County of Inyo so that the highways can be used to link existing off-highway motor vehicle trails and trailheads on federal Bureau of Land Management or United States Forest Service lands, and to link off-highway motor vehicle recreational-use areas with necessary service and lodging facilities, in order to provide a unified linkage of trail systems for off-highway motor vehicles. This will help to maintain access to some of the best Rock and Mineral collecting areas in Inyo Country.

When the Public Scoping and Planning meetings are scheduled and announced the Rockhound Community needs to jump in with both feet and be part of the process to identify the roads and trails leading to the collecting sites. This pilot program may become the model by which other counties in California may address Rockhounding and other Off Highway Recreational Usages.

Other areas of the State have not been as fortunate as Inyo County to have a legislative representative in support of and for the recreational needs of all groups. Most of the elected legislators are still trying to regulate or eliminate mechanized travel on Public Lands thus making it nearly impossible for the Rockhound Community to have access to collecting sites except by foot or horseback.

There has been an up swing in Rockhound participation by being actively engaged in Public Land Use policy decision making through the attendance at the BLM Scoping and Planning Meetings and the USFS Management Planning meetings through out the state. These public meetings are only the first steps in attempting to keep the collecting sites open and accessible to all Rockhounds. By legislative edict Public Land Usage Management requires input from all

stakeholders in open and public forums. The Rockhound Community needs to be one of these stakeholders if accesses to collecting sites are to remain open for future generations of Rockhounds. By attending and signing in to the meetings, as an individual Rockhound or as a member of a Society or Club, there is strength in numbers and the more that sign in the better. The Land Use Managers are beginning to take notice that there are Rockhounds out there and they do in fact care about the use and management of Public Lands.

When scoping or planning meetings are announced at locations through out the state, Rockhounds need to actively participate in these public meetings. Making Rockhound Voices heard is the only way to keep access to collecting areas open now and for future generations of Rockhounds.

If you have something from your area of the country to address, please contact me and we'll try and get you on the agenda. Again, mark your calendar and come and see what's going on.

We have just received word that Jennifer House, Natural Resources Specialist, Colorado River District, Lake Havasu City, AZ will be a keynote speaker at our event. This is huge because the La Posa Management Plan effecting the whole BLM area around Quartzsite is currently being studied. She will speak to this important issue.
